

1. Introduction

(a) About ICAI

The Institute of Chartered Accountants of India (ICAI) is a statutory body established by the Chartered Accountants Act, 1949 (Act No.XXXVIII of 1949), an Act of Parliament. This body is entrusted with the regulation and development of the Chartered Accountancy profession in the country. Under the administrative control of the Ministry of Corporate Affairs, Government of India, the ICAI stands as the largest professional body of Chartered Accountants globally, maintaining a steadfast commitment to serving the Indian economy in the public interest.

The governance of ICAI is overseen by a Council, operating in accordance with the Chartered Accountants Act, 1949, and the Chartered Accountants Regulations, 1988. Comprising 40 members, 32 are elected by Chartered Accountants, while the remaining 8 are nominated by the Central Government, representing entities such as the Comptroller and Auditor General of India, Securities and Exchange Board of India, Ministry of Corporate Affairs, Ministry of Finance, and other stakeholders.

Over time, ICAI has earned recognition as a largest accounting body, not only within the country but also globally, for upholding the highest standards in technical and ethical areas. It has consistently maintained rigorous examination and education standards since its inception in 1949, leading to substantial growth in terms of members and student base.

(b) About Sustainability Reporting Standards Board

The Institute of Chartered Accountants of India (ICAI) has a strong tradition of service to the country towards sustainable as well as economic development. ICAI strives to bring sustainability reporting and thinking within mainstream business practices both in the public and private sectors. ICAI through SRSB is taking proactive steps to not only identify and develop opportunities for Chartered Accountants in Sustainability Reporting but also to enhance knowledge, upskill and train members by conducting workshops, seminars, and certificate course, publish technical literature on various important topics within the sustainability domain. Further, in its endeavor to promote sustainability reporting ecosystem in the country which would lead to greener low-carbon economy, the Institute is working on two crucial aspects. Firstly, to promote compliance with existing accounting and sustainability related disclosure requirements. Secondly, to strengthen assurance framework to build a solid bridge between sustainability related risks and corporate financial reporting.

- Collaborate with national and international bodies on sustainability reporting implementation.
- Identify opportunities for chartered accountants in sustainability reporting.
- Develop audit guidance for integrated reporting.

Knowledge Sharing and Training:

- Organize webinars, seminars, and courses on sustainability reporting in India and abroad.
- Conduct "Train the Trainer" programs to build capacity.
- Benchmark global best practices in sustainability reporting.
- Organizing programs on Some of the Global days and events throughout the year focused on environmental conservation, climate change mitigation, and advancing the Sustainable Development Goals.

Recognition and Engagement:

- Establish Sustainability Reporting Awards to recognize exemplary businesses.
- Engage with and contribute to international bodies and think tanks on sustainability reporting.

Internal Measures:

- Develop awareness campaigns within ICAI about sustainability issues.
- Implement measures within ICAI to improve sustainability practices.

Knowledge Repository:

 Create and maintain a knowledge repository on the SRSB Boards page, featuring industry case studies, best practices, and expert insights.





Stock Exchange (SSE) in India, to enable Social Enterprises to obtain funds through a listing process.

Globally, Brazil has been the first country to launch an SSE in 2003, followed by South Africa in 2006, Portugal in 2009, Canada, Singapore and the UK in 2013 with Jamaica following in 2019. However, only SSEs based in Canada, Singapore and Jamaica have remained active. Most of the international platforms have had limited transactions and opportunities, mainly focusing on For Profit Social Entities rather than Not For Profit entities. The lessons from SSEs in other countries were taken into account when designing the Indian SE.


In India, the Securities and Exchange Board of India (SEBI), has enabled the establishment of SSE segments at the National Stock Exchange (NSE) and the Bombay Stock Exchange (BSE). This pioneering move is primarily aimed to bridging the funding gap faced by Social Enterprises and ushering higher levels of transparency and governance in the conduct of operations by social entities to bolster donor confidence.


